Golden Demon Painting Competition Terms & Conditions

2. The Competition

- 2.1. The competition is the Golden Demon Painting Competition (the "Competition")
- 2.2. The Competition will take place at Adepticon 2020 (held at Renaissance Schaumburg, Convention Center Hotel, 1551 N., Thoreau Dr., Schaumburg, IL 60173 USA, 847.303.4100) from 23rd - 27th March 2022 inclusive (the " Event ").
- 2.3. Please see [https://golden-demon.com] or GW's representatives at the Event for a copy of these terms and conditions.

- 3.1. To enter, you must submit your entry at the Event. Entries must be accompanied by GW's entry form. Entry forms will be available from the Golden Demon website (https://golden-demon.com), at the Event and anywhere else GW decides. Only one entry may be made per entry form.
- 3.2. All entries must be submitted to GW's representatives as directed at the Event by 4pm (16:00 hours) on Saturday
- the 26th of March 2022. Late entries will not be accepted.
 3.3. Only entries wholly painted by the entrant may be entered. Entries submitted on behalf of another person will not be accepted and joint submissions are not allowed.
- 3.4. Entries may only contain components manufactured by GW. Entries incorporating third party products or artefacts will not be considered.
- 3.5. GW will accept entries which are mounted on a presentational plinth
- 3.6. Entries must relate to one of GW's games systems, past or present.
- 3.7. Entrants may only enter once per category according to the restrictions of that category. Entrants must be eligible for the categories into which they enter. Details regarding eligibility for each category will be available from the Golden Demon website (https://golden-demon.com) and will be available from GW's representatives at the Event. 3.8. Unsuccessful entrants will be able to collect their entries from GW's representatives following judging as directed at the Event. Winners may collect their entries once the Event has finished.
